**Children's Privacy Policy**

Buteyko of Hunterdon believes that its Buteyko Method can be beneficial to children under the age of thirteen (13) years of age and it therefore makes its services available to younger persons. Accordingly, Buteyko of Hunterdon conforms its practices with respect to registering children for its services and providing said services to the Children's Online Privacy Protection Act of 1998 ("COPPA"), 15 U.S.C. §§ 6501-6506.

In addition to its general Privacy Policy and specifically incorporated herein, the following terms and conditions apply whenever personally identifiable information might be collected from a child under age 13.

1. Buteyko of Hunterdon will never require a child under the age of 13 or his/her parents to disclose more information than is reasonably necessary for participation in its services and programs. Buteyko of Hunterdon does not sell, rent or share a child's personally identifiable information with any third party and is collecting same only in order to provide voluntarily requested services or programs. The type of information that is collected is name, address, email address, phone number, age and any health issues or concerns.
2. Buteyko of Hunterdon will trigger its COPPA policy upon the first contact from a user it reasonably believes is under the age of thirteen (13) years of age. At such time, we will collect only the child's name and the parent/guardian's email address, or if none is available, a mailing address or phone number, in order to obtain the parental consent required by this policy.
3. Buteyko of Hunterdon will never collect personally identifiable information, complete his/her registration for any services or provide services to a child under the age of 13 without first obtaining verifiable consent from a parent or guardian. A copy of this site's COPPA Policy and Privacy Policy will be provided to the parent or guardian whenever consent is being sought. Because Buteyko of Hunterdon will never sell, rent or share a child's personally identifiable information with any third party and is collecting same only in order to provide voluntarily requested services or programs, it will verify parental consent by any one of the following methods:
  - a. Email from a parent or guardian followed by a delayed email confirming reply from Buteyko of Hunterdon with an opt-out/revocation reminder.
  - b. Email to the parent or guardian requesting that the parent or guardian provide consent by responding in an email followed by a delayed email confirming reply from Buteyko of Hunterdon with an opt-out/revocation reminder.
  - c. We may also request in our initial email that the parent or guardian include a phone number or mailing address in his or her reply so that we can follow up to confirm via telephone or postal mail.
  - d. Buteyko of Hunterdon may issue PIN codes to a verified parent or guardian for use for all future access to the child's personally identifiable information.

4. Buteyko of Hunterdon allows parents or guardians to access, review and control the information collected relating to a child under the age of 13 in their custody. To access, review, modify, amend or remove a child's personally identifiable information, please visit Parent/Guardian. Only persons who have been verified to be that child's parent or guardian will be permitted such access.
