General Privacy Policy

The purpose of the Buteyko of Hunterdon Privacy Policy is to advise you of the personally identifiable information we might collect, the uses to which we might put that information, how we might disclose that information, and how you can correct or update that information.

1. Buteyko of Hunterdon does not collect personally identifiable information about you except when you specifically provide such information on a voluntary basis as part of the registration process. Upon registration, the personally identifiable information about you that we may collect will include your email address, name, address, phone number, age, sex, and any health concerns of which you voluntarily advise us.
2. Buteyko of Hunterdon may collect information from individuals that are under the age of thirteen (13) years of age but only in a manner and for a purpose specified in the separate Child's Online Privacy Protection Policy.
3. Unless you voluntarily provide personally identifiable information to Buteyko of Hunterdon, we will collect only anonymous or aggregate information such as visits per page, demographics of site visitors, etc.
4. Buteyko of Hunterdon may employ cookies to allow users to navigate more easily through the site. Cookies are small text files that identify your computer to the site so we recognize repeat users. If you prefer not to allow us to use cookie technology, you should have the ability to disable cookies through your browser's features (see its help menu). However, to take full advantage of the programs or services offered (or offered in future) by Buteyko of Hunterdon, we recommend that you set your browser to allow cookies.
5. The user should be aware that any participation in a forum, bulletin board, chat room or other interactive areas of the Buteyko of Hunterdon website will require them to voluntarily disclose certain personally identifiable information to other participants, such as email or user name, as well as the message content. Buteyko of Hunterdon specifically disclaims any third party's use of information you voluntarily post in a forum, bulletin board or chat room, including use for third party marketing or to discover your identity.
6. It is the policy of Buteyko of Hunterdon not to sell, rent or share any of your personally identifiable information with non-affiliated companies or individuals. It is also the policy of Buteyko of Hunterdon to share, if at all, only non-personally identifiable information with third parties for marketing, promotional or other commercial purposes. Your name, address, email address, password, phone number or credit card information will never be disclosed without your express prior written consent.
7. We may release personally identifiable information about you if we have reasonable

cause to believe that such release is required by law; that such release is necessary to protect our rights and property; that such release is necessary to protect against any fraudulent, abusive or unlawful use of the site or other material provided, including, but not limited to, postings on any forum; or if we have reasonable cause to believe that an emergency involving immediate danger of death or serious injury to any person requires disclosure without delay and prior to our ability to obtain written consent.

8. You may change, update or remove your personally identifiable information by making a written request to Buteyko of Hunterdon. Notwithstanding same, you are advised that archived or residual information, including personally identifiable information, will remain within our databases, logs, backup media and other records and cannot be permanently removed even upon cancellation of your registration.

9. We reserve the right to change, modify, add or remove provisions, terms or conditions of this Privacy Policy at any time; however, such changes will not go into effect until we have notified you of the changes. Continued participation in the program Policy will be construed as your acceptance of such changes.
